While the recent effort of the HKSAR Government in improving Access to all public facilities is gathering momentum, the present objectives remain largely on compliance with current design standards. A much needed understanding among the building professionals is therefore required, to meet the realistic needs of the People with Disabilities (PwDs) and their rights as affirmed by the Disability Discrimination Ordinance.

The seminar is to reinforce this concept by introducing a proper Perspective of "Access to Premises" in the Hong Kong context, together with an outline of the specialist role of Architects in Access Consultancy both locally and internationally.
