PhD Architect/Public Health

**Professor Alan Dilani** is the Founder and Director of the International Academy Design & Health, Sweden. He has been engaged worldwide in several universities, both medical and design institutions, in the field of design and health to develop "Psycho-socially Supportive Design Program". His research at *Karolinska Institute, Medical University*, developed a multi-disciplinary research approach leading to a new definition called "Salutogenic Design" - that not only fosters functional efficiency, but also improves health processes.

Alan has designed all kinds of healthcare facilities and was advisor to several ministry of health around the world. He lectures worldwide and is the author of numerous articles and books on design and health. Dr. Dilani received the Award 2010 from *US Academy of Architecture for Health* for his promotion of high quality design research.

**Calvin Luk** is the Consultant Architect of RehabAid Society (Environmental Advisory Service) and a clinician of Chinese Medicine specialized in acupuncture. Now he leads a team of architects and therapists to provide professional advice in accessibility and design of elderly /disabled /Dementia care facilities in Hong Kong and China. His research interest on healing environment draws on TCM as an interdisciplinary approach to bridge Salutogenic theory and wellness factors by design. Calvin is also Founding Chairman of *Association of Universal Accessibility Hong Kong*, an alliance of multi-disciplinary professionals and key stakeholders promoting equal access for all.
